APPOINTMENTS TO
GUARDIAN AD LITEM REVIEW BOARD

Effective November 14, 2017

WHEREAS, the Maine Supreme Judicial Court adopted the Maine Rules for Guardians Ad Litem,

WHEREAS, Rule 7 of the Maine Rules for Guardians Ad Litem establish the Guardian Ad Litem Review Board as an independent unit within the Board of Overseers of the Bar to administer the regulation of guardians ad litem,

WHEREAS, Rule 7(a)(2) provides that the Maine Supreme Judicial Court shall appoint twelve people to serve on the Review Board, eight of whom shall be on the roster of guardians ad litem and four of whom shall be public members, and shall periodically designate one member of the Board as Chair and another as Vice Chair,

WHEREAS, the terms of Dana Prescott, Esq., of Saco; Karen Boston, Esq., of Augusta; Catherine Miller, Esq., of Portland; Malcolm Dow of Hollis Center; and Brenda Harvey of Gardiner, expired on September 1, 2017 and are eligible for reappointment;

NOW, THEREFORE, all of the Justices concurring therein, it is hereby ORDERED that:

Dana Prescott, Esq., of Saco; Karen Boston, Esq., of Augusta; Catherine Miller, Esq., of Portland; Malcolm Dow of Hollis Center; and Brenda Harvey of Gardiner are hereby reappointed as members of the Guardian ad Litem Review Board to serve until September 1, 2020.

Amanda Beal Day, Esq., of Bangor is hereby appointed as a member of the Guardian ad Litem Review Board to serve until November 14, 2020.

Dana Prescott shall serve as Chair of the Guardian ad Litem Review Board.

Dianne Tennes shall serve as Vice-Chair of the Guardian ad Litem Review Board.

Justice Joseph M. Jabar shall act as Judicial Liaison to the Guardian ad Litem Review Board.
