Only the Public Records Indices of Okaloosa County provided in the Okaloosa County Courthouse in Crestview or the Okaloosa Courthouse Annex Extension in Ft. Walton Beach shall be referenced as the Official Public Records Indices. In any situation where the Official Public Records Indices differs from the online version, the Official Public Records Indices will take precedence.

The Okaloosa County Clerk of Court disclaims any responsibility and makes no representations or warranties as to the quality, accuracy, content, or completeness of any information contained in this website. Assessing accuracy and reliability of information is the responsibility of the user.

Users will be notified when they can access the online court system.
