LAGRANGE, JR.** (dob: 02/16/1999), did with the use of a firearm, namely a Glock 10mm model 29 (serial number: ZPG479), intentionally or knowingly cause the death of another human being, namely **MICHAEL J. HAYTER** (dob:12/19/1981), all in violation of 17-A M.R.S. § 201(1)(A), §1504(1)(B).
